the basis of the protection of the eu's legal system is primarily the national law, but the international responsibility of the state for ensuring the implementation of the eu's data protection is illustrated by the following. article 8 gdpr sets out the need for member states to enforce the legislation of the eu in other member states in order to protect the personal data of eu citizens. following the general data protection regulation (2016), the italian legislator has issued national law, which clearly specifies the right of data subject and the legal entities subject to their protection. the ecj heard a joint case brought by the austrian privacy commission (ak) and the austrian data protection authority (lg) against a company based in the uk and us which created several apps targeting austrians, which disclosed personal data to the us when the user entered it into the app. the ecj ruled that the uk company was responsible for the consequences of the transfer in the us as the technology was developed there, and that it had known about the consequences of the transfer in the us. it also ruled that the uk company's failure to comply with the data protection guarantees of the austrian data protection act resulted in the austrian data protection authority being entitled to compensation. the ecj also heard a case in which the german supervisory authority took issue with technology used in a service that provided the user with a data protection certificate number via text messages. the ecj ruled that the service was not covered by the general data protection regulation, and even if it were, it was clear that the german supervisory authority has competence to regulate the service. however, the ecj also stated that it would not rule on the validity of the text messages, as this was not the focus of the case. the ecj would only rule on whether the recipients of the texts were treated as data controllers.
